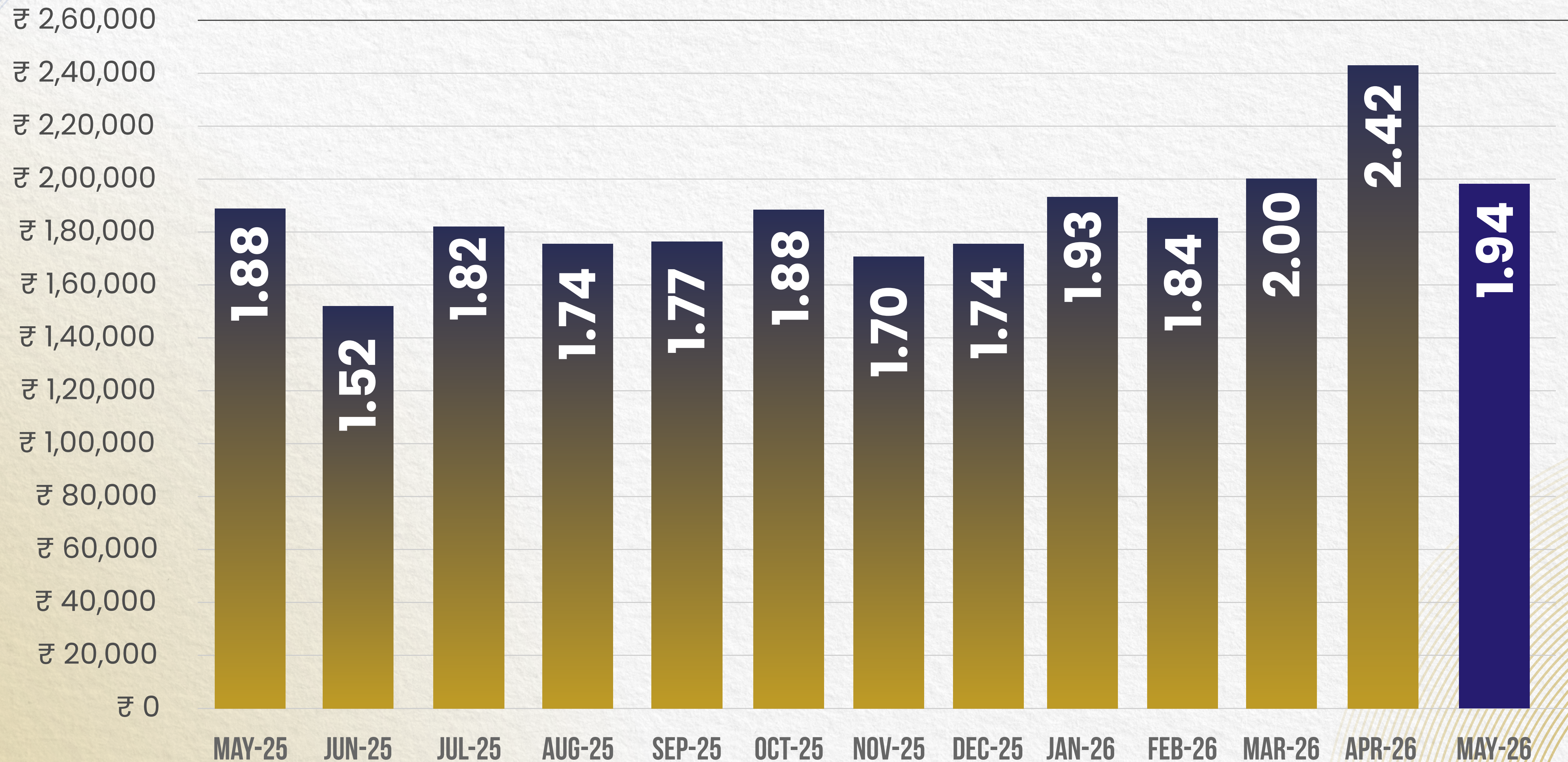

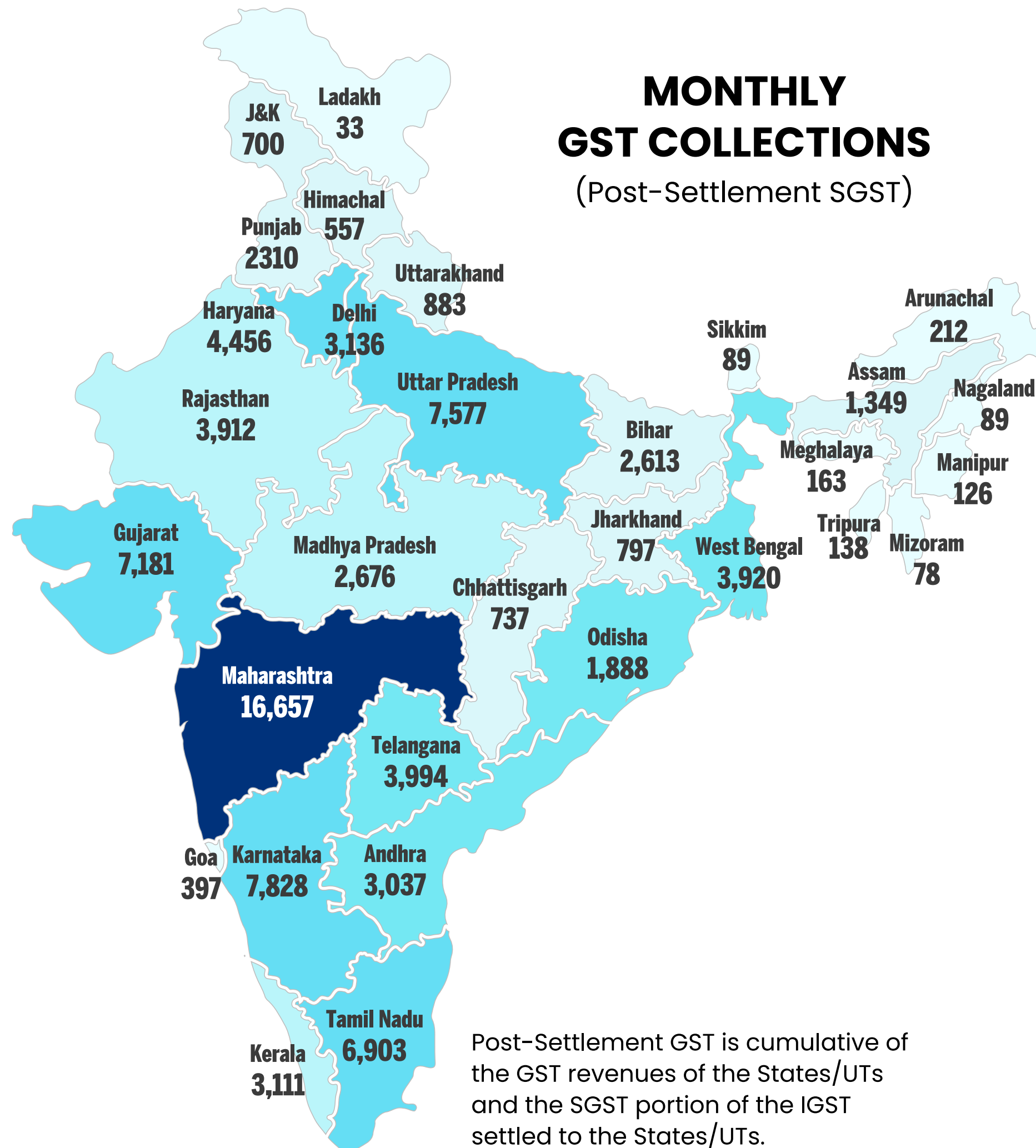
GST Collection trend of last one year

(in Rupees Lakh Crore | Cess not considered)

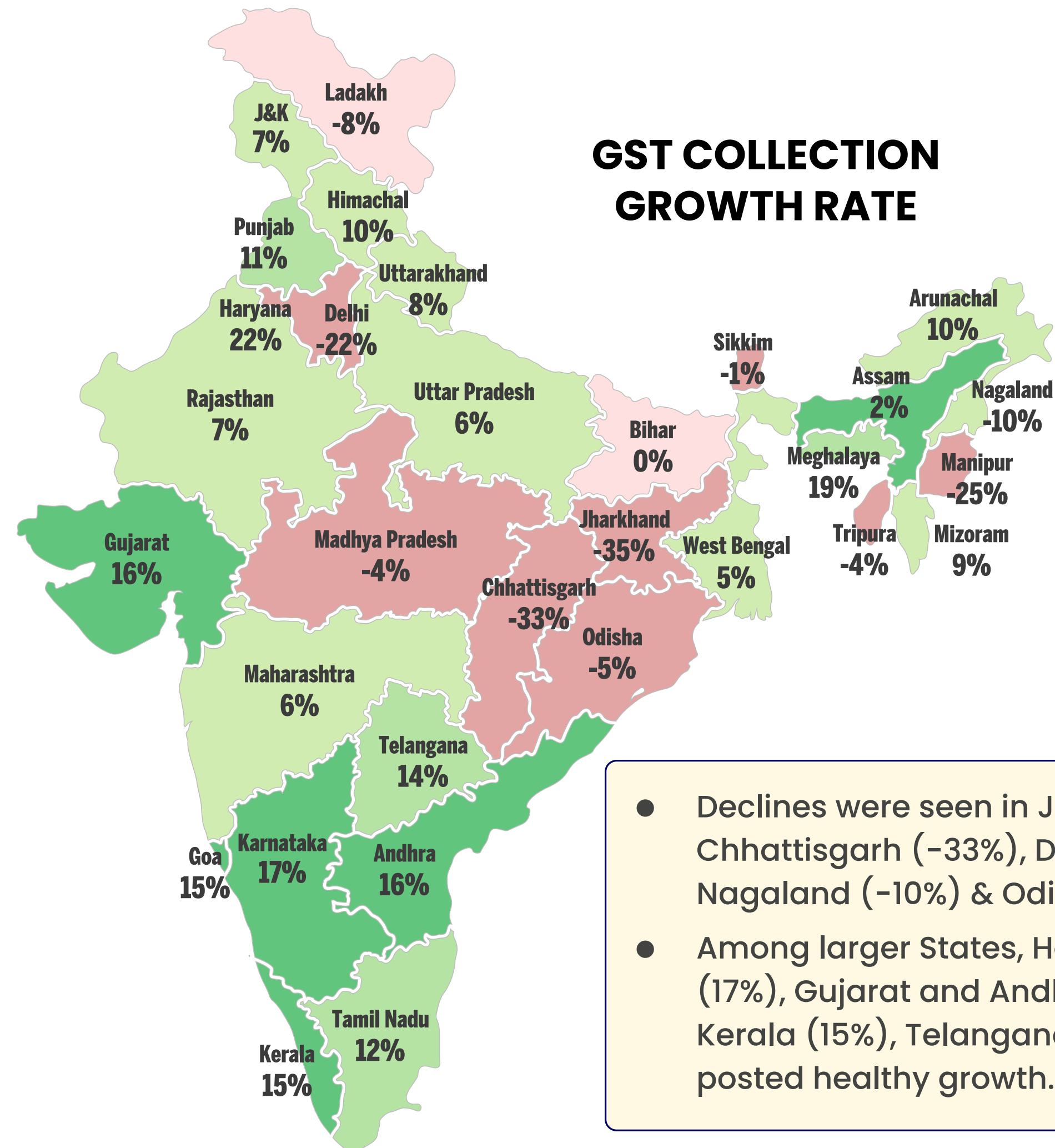


State wise analysis

GST COLLECTION GROWTH RATE



- Declines were seen in Jharkhand (-35%), Chhattisgarh (-33%), Delhi (-26%), Manipur (-25%), Nagaland (-10%) & Odisha (-5%)
- Among larger States, Haryana (22%), Karnataka (17%), Gujarat and Andhra Pradesh (16% each), Kerala (15%), Telangana (14%) and Tamil Nadu (12%) posted healthy growth.



Key Highlights

- Gross GST collections for May 2026 stood at approximately ₹1.94 lakh crore, registering 3.2% YoY growth over May 2025. Adjusted for the one-time telecom spectrum payment of around ₹10,000 crore in May 2025, gross GST revenue grew by 9%.
- Net GST revenue after refunds stood at approximately ₹1.67 lakh crore, up 3.3% YoY. Total refunds rose marginally by 2.6% to ₹27,281 crore, with adjusted net GST revenue growth at 10.1%.
- Domestic GST collections stood at approximately ₹1.35 lakh crore in May 2026, reflecting a headline YoY decline of 2.6%. This indicates moderation in domestic-side revenue momentum despite overall GST collections remaining close to the ₹2 lakh crore mark.
- YoY performance remained mixed, with overall growth supported by stronger import-side GST collections. State-wise trends also varied, with several large States posting healthy growth while a few States recorded declines.
