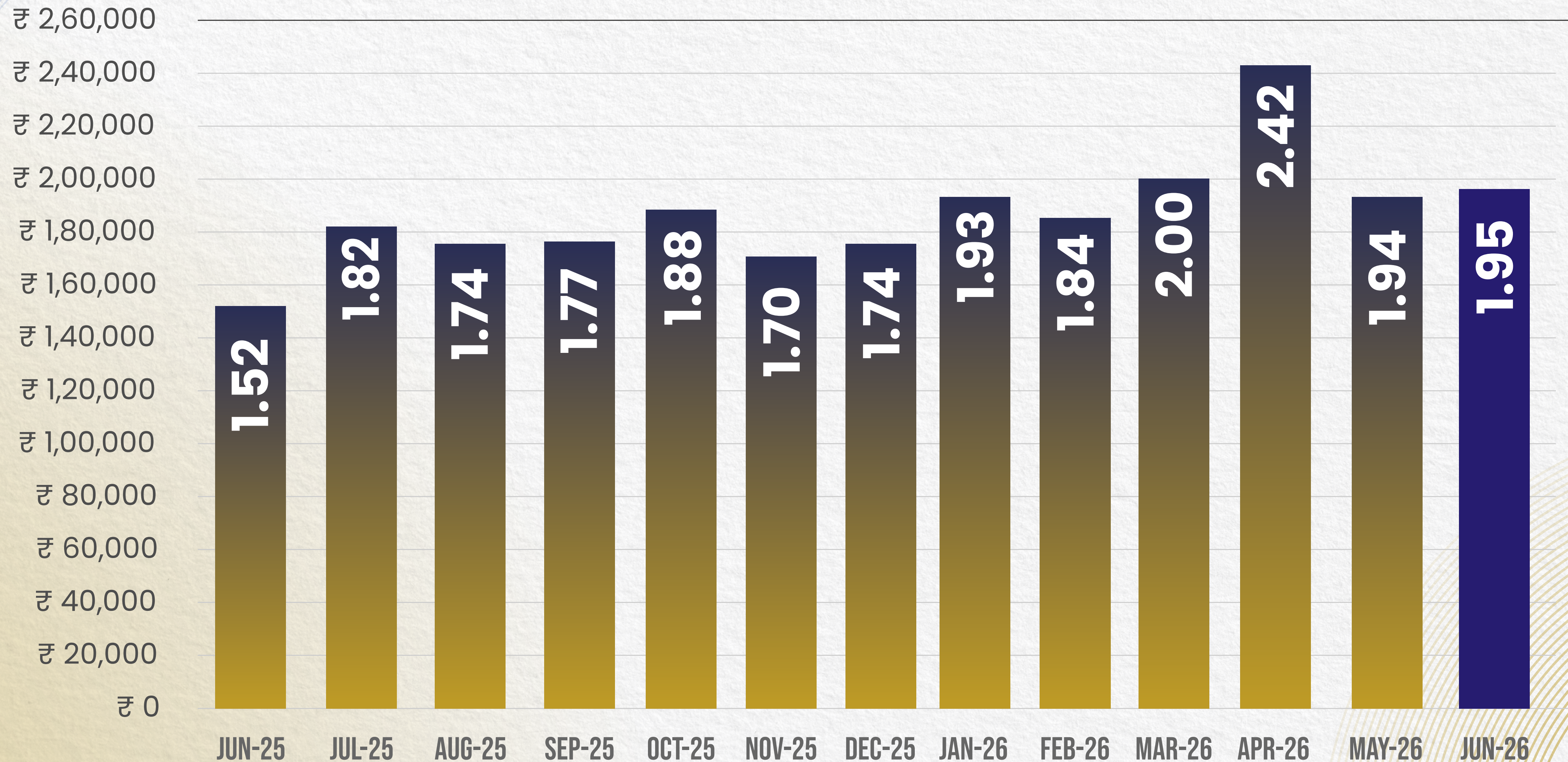

GST Collection trend of last one year

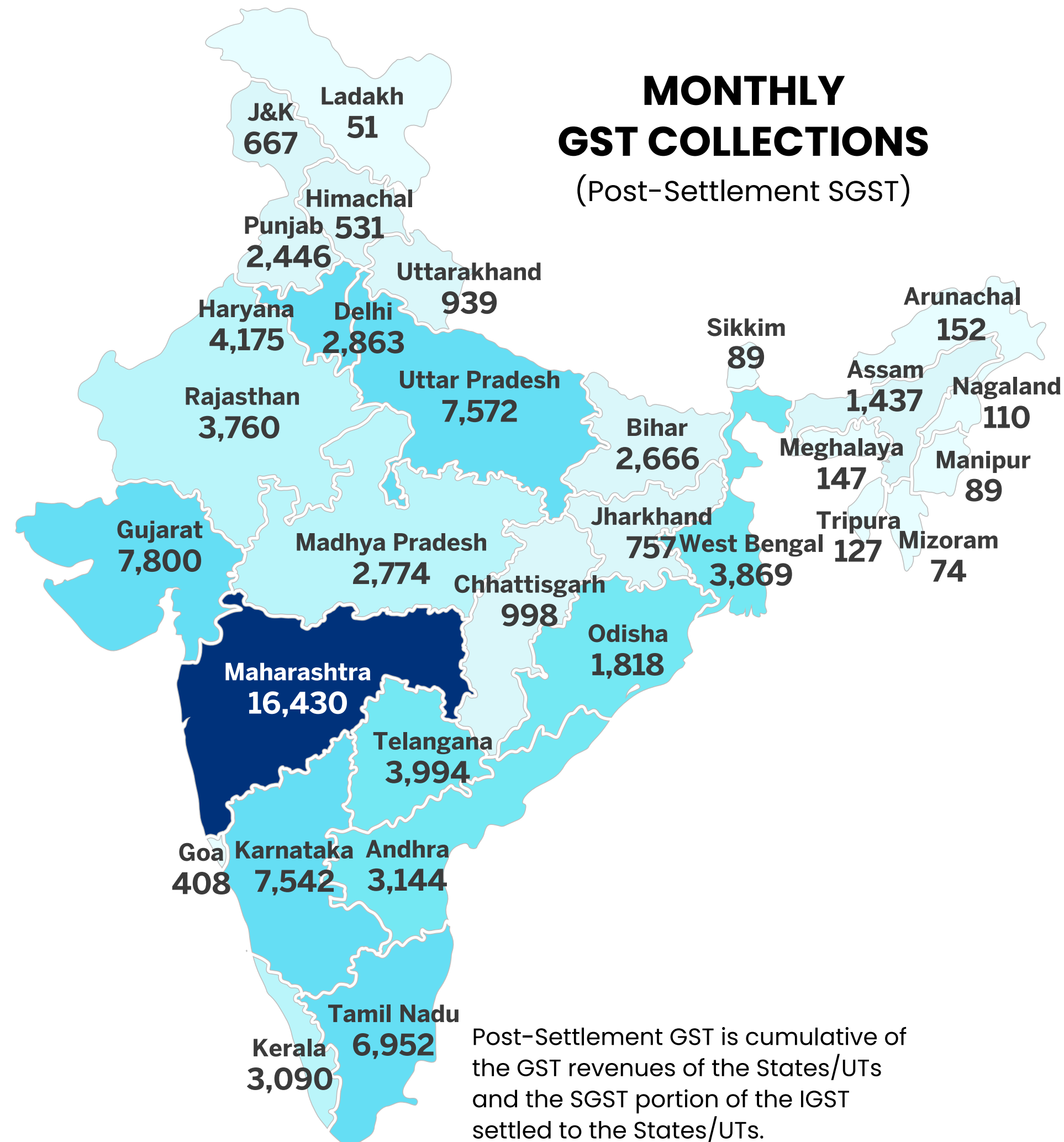

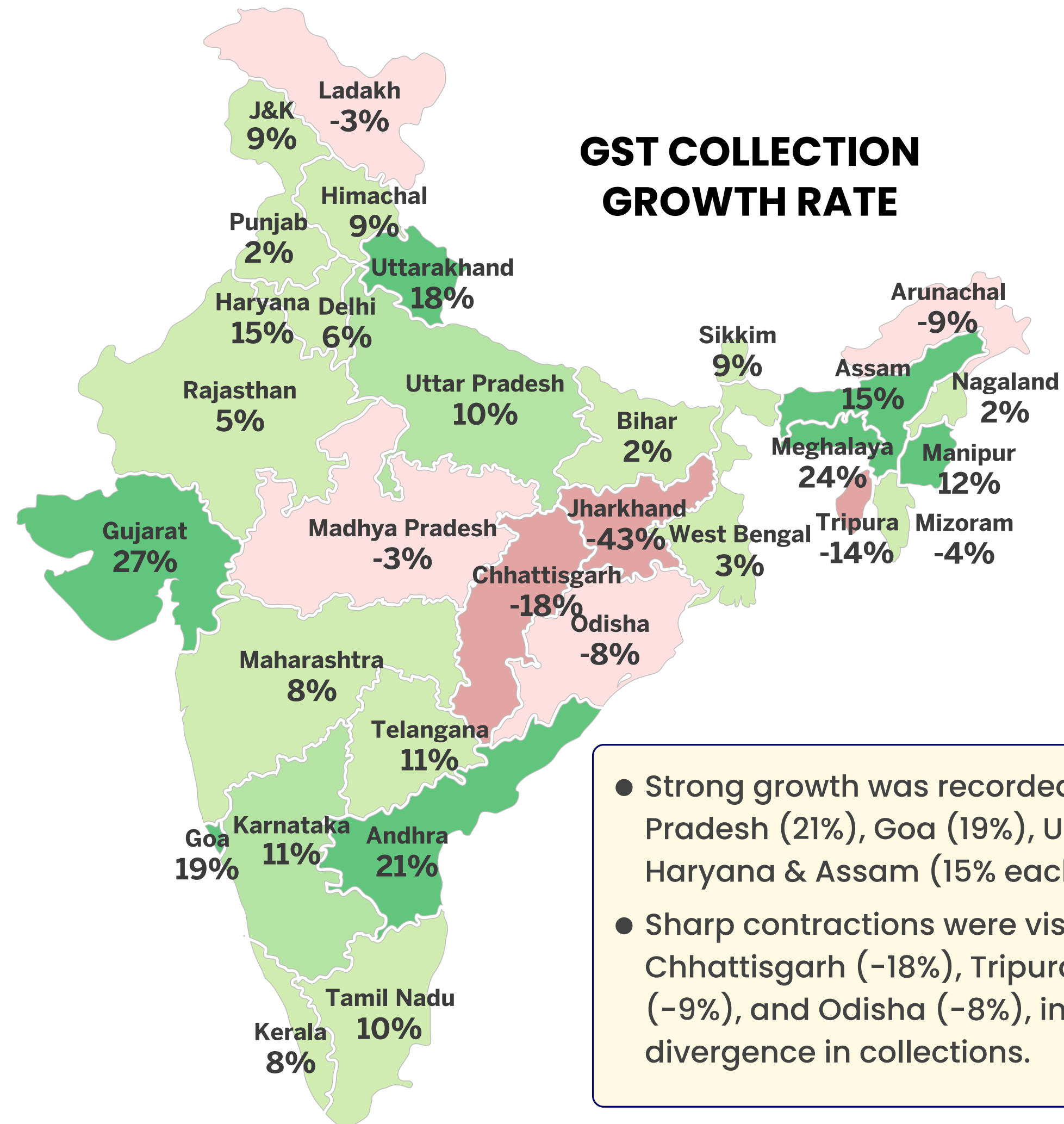
MONTHLY GST COLLECTIONS

Post-Settlement GST is cumulative of the GST revenues of the States/UTs and the SGST portion of the IGST settled to the States/UTs.

GST COLLECTION GROWTH RATE



- Strong growth was recorded in Gujarat (27%), Andhra Pradesh (21%), Goa (19%), Uttarakhand (18%), and Haryana & Assam (15% each).
- Sharp contractions were visible in Jharkhand (-43%), Chhattisgarh (-18%), Tripura (-14%), Arunachal Pradesh (-9%), and Odisha (-8%), indicating continued regional divergence in collections.



Key Highlights

- Gross GST collections for June 2026 stood at approximately **₹1.95 lakh crore**, reflecting a strong **13.9% year-on-year growth** over June 2025 and keeping monthly collections close to the ₹2 lakh crore mark.
- Domestic GST collections grew **6.5% YoY** to **₹1.35 lakh crore**, indicating steady domestic activity. In contrast, GST on imports increased sharply by **34.6% YoY** to **₹60,038 crore**, emerging as the key growth driver for the month.
- Net GST revenue after refunds stood at approximately **₹1.62 lakh crore**, registering **11.2% YoY growth**. Net domestic revenue grew moderately, while net customs revenue expanded sharply, reinforcing the import-led momentum in June.
- FY27 year-to-date gross GST collections aggregated to approximately **₹6.32 lakh crore**, reflecting **8.4% YoY growth**. Net GST revenue for April–June stood at around **₹5.40 lakh crore**, up **7.1% YoY**, keeping cumulative collections on a stable growth path.
